



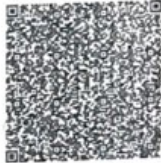

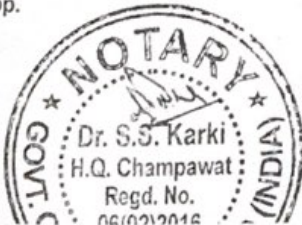

6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any in manner without obtaining affiliation.
7. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from the time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, direction issued from time to time and the and the law of the land.
8. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. With respect to the school and staff of the school.
9. That the school will ensure that the Building Safely, Fire Safety, Water Safely, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to as per the prescribed term.
